Befriend Motherwell Trustees' Annual Report

Year ended 31 December 2023

Structure, Governance and Management

Structure Governance & Management Constitution The Charity is an unincorporated association. It is governed by its constitution. The Charity was granted charitable status by OSCR on 27 January 2015. The management committee, which normally meets on a quarterly basis, are the Charity's trustees. Receipts and Payments Accounts are prepared in accordance with OSCR statement of recommended practice. The trustees may co-opt further trustees if they consider it would be in the interests of the Charity so to do. The trustees are responsible for the strategic direction and governance of the Charity whilst day-to-day running is delegated to the Coordinator and assisted by the staff team. Client visits and group support are carried out by unpaid volunteers. The Coordinator attends Trustee meetings as required to discuss progress and development. The Trustees are particularly aware of their responsibilities for Health and Safety, and all staff, paid and unpaid volunteers, have disclosures under During the year there were eight Trustees in total at present with a wide range of skills.

Organisational Structure

The Trustees meet as a Management Committee for Strategic Direction and Governance. Day to day running is carried out by four paid part time employees consisting of Coordinator, Development Officer and an Intergenerational Officer, and Group Facilitator. The Coordinator and team oversee the activities of the volunteer Befrienders who visit the Befriendees and support the four groups which meet on a weekly basis along with our various other events and activities.

Objectives and Activities

Concern for the many lonely and isolated elderly residents in the town lies behind the initiative launched in 2011 to establish a Befriending Service based at Dalziel St Andrew's Parish Church and in 2012 a year's Pilot Project was initiated to strive to create up to 15 "matches" between volunteer befrienders and befriendees. The objective was to tackle some of the isolation faced by the many elderly in Motherwell who feel so alone. Following the initial success, and with additional funding support from the Local Change Plan, work started in 2013 on Group Befriending with five groups formed by the end of 2018. This enabled groups of elderly to meet in their own environment and join in shared activities.

After five years of successful activity, in 2016, a successful application to the Big Lottery Fund was made which allowed for the expansion and growth of the organisation. This included developing new intitiatives, groups and Intergenerational Working; all of which has continued to flourish.

One of the conditions of the grant was to work towards the Quality in Befriending (QiB) Excellence Award which was achieved in November 2019. The QiB Excellence Award was reachieved in 2022.

2023 was another successful year for Befriend Motherwell with the securing of a further three years financial support from the National Lottery Community Fund which allowed us to focus our energies towards the impact we can make in supporting people. We have been pused a lot by volunteer recruitment and development over this last year to help towards increasing our capacity. Alongside our core work we always aim to find new initiatives to help us support our participants as best we can. One of these things has been the introduction of weekly chair Pilates classes. This has built upon our hugely successful weekly chair yoga classes where over 60 people attend weekly. The addition of chair Pilates has been positive with people being able to engage in more supported exercise to help their physical and mental wellbeing. During the summer months we were delighted to offer trips and outings to our participants. These included visits to the seaside, the Safari park and Peebles. The feedback from these activities was very positive and it was enjoyed by everyone involved.

We reintroduced our Musical Memories events where we give people the opportunity to get together for a sing-a-long and reminisce on music they enjoyed when they were younger. Studies highlight that music is very emotive for people particularly older adults who are living with dementia. We ran several more successful Intergenerational Projects, this time focusing on activities and tasks that were 'lowerkey' to allow more attention to be put upon the relationships between the different generations being developed and helping to diminish some of the stigmas around young people and older adults.

This year we ran a ten-pin bowling trip for all of our participants where they were supported to take part. This was really appreciated and enjoyed by folks.

On top of these things we've organised various events quarterly over the year where participants have enjoyed tome together with others, entertainment and some food. Feedback from our events has always been positive.

We were delighted to introduce a new befriending group within a different venue in the area that we work in. This group has proved to be very popular so far and feedback from it has been very positive

Befriend Motherwell continues to be very appreciative of the financial support offered by several organisations. Through 2023 this support came from The Big National Lottery Community Fund, Dalziel St Andrew's Parish Church, Adsa Foundation, Voluntary Action North Lanarkshire, North Lanarkshire Council in respect of the Warm Spaces initiative and numerous individual donations. The Trustees of the Charity particularly wished to record their thanks to all Befriend Motherwell staff for their work on the project during the year and also to the many Volunteers who commit so much time to realising the aims of the Project in working, in so many ways, to reduce loneliness and isolation for elderly in the town. Although not all of our Volunteers choose to be reimbursed for their expenses all are advised that an allowance is included within our accounts to ensure they are able, if they wish, to receive appropriate reimbursement. A relevant reclaim form is made available to all. Evaluation and feedback forms a most important part of the projects work to ensure that we continue to deliver the

Financial Review

Funding is received from an annual donation from Dalziel St Andrew's Parish Parish Church and Grants received from the various Fund providers as listed on page 5 and who have an interest in the activities the Charity provides for the Elderly. All Funding received from the various funding bodies is for the purpose of core Befriend Motherwell Activities is Restricted funding and can only be used for core activities. There remains Lottery funding (largest provider) for 2 more years and the Trustees recognise it is a major challenge to secure match funding which comes near to the level of support granted by the Lottery. The Trustees will continue to closely monitor funding implications for the Charity.

Reserves Policy

All funding relates to the ongoing day to day operations of the Charity and No Financial Reserves are held by the Charity.

Statement of Trustees' Responsibilities

The Trustees must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Charity during the financial year. The Trustees are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Charity at that time.
