## **Structure, Governance and Management**

### **Constitution**

The Charity is a Scottish Charitable Incorporated Organisation (SCIO). It was registered in its current legal form on 18 November 2015. It was set up with a single-tier structure.

### **Appointment of Trustees**

The Board of Trustees, which normally meets four times per year, are the Charity Trustees. Membership of the Board is open to anyone with an interest in our charitable purposes.

New Trustees are elected at the Annual General Meeting which normally is held in November. There must be a minimum of 3 and maximum of 12 Trustees. At each Annual General Meeting one third of our existing Trustees will stand down.

### **Objects and Activities**

#### **Charitable Purposes**

- To provide a range of opportunities for experiential learning in a fun, creative and safe environment that supports people to reach their full potential and contribute to the local community.
- Encourage individuals and communities to engage with nature and deliver volunteer-led solutions to help improve the environment.
- Work in partnership with other agencies and organisations to identify opportunities to use and/or reuse natural materials and provide training, support, practical education and awareness sessions.

#### **Activities**

As part of our work Natural Connections is developing an old gasworks site in Tranent, East Lothian that has lain unused since 1978. We have volunteers coming along every week to help clear the site also removing all the rubbish. We are providing opportunities that are lacking in the Tranent area, where people can learn about horticulture and, for some, use the garden for therapy and rehabilitation or to improve employment prospects. To the wider community we offer a natural communal space for events, garden/environmental training workshops, arts and crafts and seasonal cooking and healthy eating.

So far, we have been busy building sheds and creating raised beds. We have also put in Polytunnels to extend the growing season and an orchard and herb growing area. We have also built an outdoor kitchen and wood burning brick oven for holding seasonal cookery sessions. We have also completed our Nature Play area which includes a campfire /outdoor cooking area and woodland for nature and environmental activities.

#### **Achievements and Performance**

The garden is a place where people can come along and learn about organic growing: as well as helping to transform what was once a derelict site into a place for the local community to enjoy. Since 2014 we had a small group of volunteers coming along each week working together and learning a variety of skills.

We now have a group of up to thirty volunteers coming along on a regular basis. The garden now provides a wide range of training, volunteering opportunities and recreational pursuits for local people. The garden has become an attractive place where



people can learn about organic growing and a vibrant community space that will encourage individuals, groups and organisations, schools and the wider public to learn and engage in environmental, social and health activities.

We now have two open garden sessions a week with a regular team of volunteers supported by Community and Corporate groups coming along during the season. We have two groups coming along each week from Edge Scotland, an organisation supporting young adults with Autism.

## **Financial Review**

### **Income £13512.98 & Expenditure £14823.94**

We were partially successful with The Year Four Community Mental Health and Wellbeing Fund who awarded us £10000 from an initial £13500 application. This is to continue with the garden Outreach work. We were also awarded £2700 from the Fa'Side Area Partnership to cover the costs of the Professional Tree Removal as well as additional staff time.

## **Reserves Policy**

At this time Natural Connections does not hold any reserves.

## **Plans for the Future**

We aim to provide opportunities that are lacking in the Tranent area where people can learn about horticulture and, for some, use the garden for therapy and rehabilitation or to improve employment prospects. To the wider community we offer a natural communal space for events, garden/environmental training workshops, arts and crafts and seasonal cooking and healthy eating. With crafts in mind, we are creating a willow planting area from which we can coppice our own willow for weaving and basket making. Funding is currently in place to carry out garden Outreach sessions, helping people to grow fruit and vegetables in their own gardens.

## Independent Examiner's Report on the Accounts
