

Charity Reorganisation – Summary of Application

Type of Scheme

W J Underwood's Testamentary Trust (SC001625) ("the charity") has applied to the Office of the Scottish Charity Regulator (OSCR) for approval of a reorganisation scheme for a variation of the constitution of the charity (whether or not in relation to its purposes) under section 42(3)(a) of the Charities and Trustee Investment (Scotland) Act 2005 (the 2005 Act).

The charity's constitution is a Will dated 11 October 1983 and registered in the Books of Council and Session on 11 May 1987. The object of the charity is for the benefit of medical research in Edinburgh directed to achieve prevention of, cure for or relief from pain and illness.

The trustee proposes to make following changes to the constitution:

Introduce new provisions via a supplemental Deed of Trust which will give the trustee new powers to advance capital and have the option to wind up the charity if necessary.

Reasons for reorganisation

The charity trustee has identified the charitable purposes can no longer be effectively and economically fulfilled. The original Deed of Trust requires amendments in order to provide the trustee with a necessary power to advance the capital of the trust. This will allow for a potential future plan to transfer the trusts property to Tenovus Scotland (SC009675) a charitable body which has received the income of the trust for the last few years and has purpose of advancing health by supporting medical research.

Reorganisation condition

The trustee suggests that the following reorganisation condition is met:

S42(2)(d) of the 2005 Act that it is desirable to introduce a provision (other than a provision setting out a new purpose) to a charity's constitution

The trustee suggests the condition is met because:

The Trust Deed no longer provides an effective method of using the trust property due to low annual income and significant administrative costs. The trustee has recognised the charity's Deed of Trust does not possess any provisions which would give the trustees the power to consider a transfer of property to another charity or the power to wind up if it so chooses.
