We have monthly meeting within our association, where we discuss what we have on in the next weeks ahead and any purchases we have made is spoken about and the up-to-date accounts are available for the whole group to see.

We are also looking to expand our area and we are in talks with FVA on all the legalities of this and the move to new premises. We are a valued asset in the community Trusted by many and needed by all. Our need is great and we are going from strength to strength.
