As part of its health and wellbeing focus, the charity invited Mandi Moore to speak to members on health and wellbeing matters. This provided an opportunity for members to gain awareness and encouragement around personal wellbeing.

IWAG also collaborated with other community associations during the year, including participation in cultural dance activities with the Igbo Union. These activities helped promote Igbo culture and heritage while encouraging unity and community participation.

Overall, It continued to meet its charitable purposes by supporting women, promoting wellbeing, preserving cultural heritage, and strengthening community relationships.
