The last year has been particularly encouraging for Providence Christian School. Two new pupils joined in August 2024, bringing the school roll to 13, and there is an expectation that this will grow significantly after the summer. There continues to be a junior and a senior classroom, and the teaching is shared by and is also supplement by volunteers. We extend our gratitude to all the staff and volunteers for their dedication, commitment and sacrifice in the great work of educating young people in preparation for a life of service to God and to the world. The school was visited recently by HMIE as part of their Annual Engagement Visit, and the feedback recent was overwhelmingly positive.

The children continue to learn in a vibrant and nurturing environment. As well as focusing on the core subjects of reading, writing, and mathematics, they also have opportunity to take part in a wide variety of other activities such as art, music, P.E., gardening, etc. These subjects are all delivered in an environment which is shaped by the Bible, and which demonstrates to the children that all of life exists under the sovereignty of God.

The Mother and Toddler Group continues to run successfully and is a weekly highlight for the children in the school who actively participate. Quarterly Prayer Meetings are held at the school and are normally led by Ministers from local churches. A huge amount of work is carried out by Board members on various sub-committees. Particularly notable has been the development of a new website over the last year, as well as exciting progress in plans to development a secondary school.

We continue to be thankful for those who generously support the school financially and have been humbled to receive significant donations over the year. The fundraising committee has also been very active. Particular thanks are extended to the John Knox Foundation in the Netherlands, who continue to make considerable financial contributions to the school.

More than ever, we are convinced that Christian education is to promote the spiritual health of our children, and the Christian good in Scotland for future generations. We give thanks to the Lord who continues to prosper the school, and we pray that all of the glory will be His.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF LEWIS CHRISTIAN EDUCATION ASSOCIATION
