Trustees' Annual Report

Year Ended 31 December 2023

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Model Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session and Congregational Board are the charity trustees. The Kirk Session consists of the minister and the elders. The minister is elected by the congregation and inducted by the Presbytery. The elders are chosen from those members of the congregation who are considered to have the appropriate gifts and skills. The Kirk Session is chaired by a Moderator and this position is occupied by the Moderator on 28 April 2022 by Presbytery. The. **Session Construction** was appointed Interim Moderator on 28 April 2022 by Presbytery. The. **Session Construction** was appointed Interim Minster in the parish serving two days per week and each Sunday.

was ordained as an Elder on 9th April 2023 and admitted to the Kirk Session.

The elected members of the Congregational Board are members of the congregation who are not elders and who are considered to have the skills and commitment to contribute to the management affairs of the Church: they are elected at the Stated Annual Meeting of the Congregation and serve for three years, when they are eligible for re-election.

Organisational Structure

Normally the minister, currently the Interim Moderator, is Moderator of the Kirk Session, which normally meets on six occasions each year and is responsible for the spiritual affairs of the Church. The Congregational Board is chaired by the minister, currently by the Interim Moderator, and normally meets five times per year with additional meetings as required: it is responsible for matters relating to finance and property.

The minutes of these meetings are in the Kirk Session and Congregational Board minute books. During the repair and refurbishment project a Working Group has been established to oversee the project. This group is currently acting as the Property Committee.

A Steering group was set up at the Annual Stated Meeting to take forward the proposed Union with Abercorn Parish and had their first meeting on 4th September 2023. After due process the Basis of Union and Basis of Reviewable Charge was completed and approved by the Congregation on the 26th November 2023 and by Edinburgh and West Lothian Presbytery on 5th December 2023. This change was submitted to OSCR for approval and they have given their consent to the proposed change of name and the official date for the change of name is 1st February 2024. The legal name of the United congregation will be 'Abercorn Pardovan Kingscavil and Winchburgh Parish (Church of Scotland)' and the Scottish Charity number 'SC026230 will be retained. From the 1st of February 2024, the Church will be administered in accordance with the terms of the Unitary Constitution.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond. Pardovan Kingscavil and Winchburgh Church is linked with the parish of Abercorn and worship is held in Winchburgh

every Sunday. Worship is held in Kingscavil Church on the first and third Sundays of the month. When there are five Sundays in the month worship is held in Kingscavil Church alternating with Abercorn Church. A car rota is in place to enable older and less able members to attend Sunday Worship.

The congregation is served by an Ordained Local minister, the Rev Derek Henderson, who was appointed Locum Minister by the Kirk Session on the 25th May 2021, to work each Sunday and two days per week and from 28 April 2022 as Interim Moderator.

Again, much effort has gone into improving Winchburgh Church to serve the needs of the worshipping congregation and the wider community.

Our objective remains to raise sufficient funding to have the welfare facilities upgraded in Winchburgh Church. Plans are being produced and tenders for the work to go out early in 2024. Our aim is to add a small kitchen and accessible toilets within the sanctuary of Winchburgh Church, to allow for a wider range of use of the church and for community use.

The Board continues to use the services of an architect first engaged in October 2021 to supervise the project. During 2023 many meetings were held with the Architect, General Trustees, Presbytery representative and Working Group to progress the project.

Decoration of the areas where structural work was completed in 2022 will be done when the new internal welfare facilities have been completed.

The marquee has been a valuable resource for church activities and remains a useful space for various activities throughout the year.

Achievements and Performance

Holy Communion was celebrated in-person during 2023. There are 204 members on the Communion Roll and 18 on the Supplementary Roll. Children attend worship with parents or grandparents occasionally.

Children and Young People. We have co-operated with Linlithgow Young People's Project (LYPP) in the past, however, because of their issues with staffing we have had no involvement with them in Winchburgh Church during this year.

The Mission Hall in Bridgend however has been used by LYPP for family café style activities linked to their youth club in Bridgend Community Centre. We also provided premises in the Mission Hall for a Scottish government funded tutoring service for S4-6 pupils in need of support in the academic year 2022-3.

We have developed a strong link with a local private nursery whose children attend the weekly "Coffee and Chat" in Winchburgh Church. The children were involved in the 2023 Christmas Tree Festival in Winchburgh Church, as were pupils from Winchburgh Academy and Winchburgh Primary School, Winchburgh Children's Gala Day and Winchburgh Wombles children's environmental Group. Winchburgh Guides and Winchburgh Rainbows were also involved in the festival and meet weekly in Winchburgh Church.

We support the West Lothian Foodbank by donating food items and a special donation of collections from events leading up to Christmas was much appreciated. We also support Winchburgh Food Store, who have a distribution point for surplus items in our grounds.

A wooden bench was gifted by Lodge Hopetoun St John 1232, it is sited in the Garden of Remembrance. A welcome enhancement for people who come to visit this place.

An open house event to watch the live broadcast of the coronation of King Charles III was held in Winchburgh Church. This was very well attended.

A cherry tree was planted in Winchburgh Church grounds; this tree was dedicated, on 7th May 2023, to mark the coronation of King Charles III.

The church website is active, the website and the PKW Facebook page are updated regularly, services are live streamed every Sunday from Winchburgh Church.

A Christmas card expressing good wishes to all and listing the events during December was delivered to all the houses in the parish.

Over the past few years, an enormous number of new houses have been built in Winchburgh with further development to come and 3 new schools built, 2 of which opened in August 2022 the other opened in August 2023, with some recreational facilities available to the public, so communication will be more important and challenging in the future.

An invitation was extended to all three new schools and the existing primary school to attend an Act of Remembrance, which was held on Friday morning, 10 November. The head teachers and two pupils from all four schools attended with wreaths laid by each school.

The Christmas celebrations events and services were well received by the congregation and others; Christmas events were organised including a Santa sleigh visit around the Parish and Santa's Grotto at Winchburgh.

A special Nativity service for children and families was held on Christmas Eve in Winchburgh Church and was attended by 75 people, including 23 children.

Bathgate Concert Orchestra gave a concert in Winchburgh Church in December.

Fundraising events and opportunities resumed throughout the year and some members took individual initiatives to raise funds.

The Craft Club has met throughout the year, meeting in March, April and May in the Session House or the Church. Some people did work on plastic canvas making Easter, Hallowe'en and Christmas novelties; others were knitting baby blankets, baby and children's cardigans / jumpers and clothes to dress teddies, all profits for church funds.

Fundraising events were held in the marquee and Winchburgh Church. Summer fete in June, car boot and table top sale in Winchburgh Church and grounds in August, sponsored walk in September, Christmas Fayre in Winchburgh Church, Christmas tree festival in Winchburgh Church in December, was combined with Santa's Grotto. 16 local organisations (including schools) decorated trees for the festival.

Warm Space initiatives in conjunction with Winchburgh Community Development Trust were held during the year in Winchburgh Church.

All these events were well supported by the wider community and were financially very successful. As ever, we are grateful to the office bearers, members and many volunteers who give of their time, talents and money in furthering the work of the Church, both here and abroad. We also appreciate the support of the people in our community.

Financial Review

The Church end of year figures showed that there was a deficit in year of £6593 in the General Fund (2022: Deficit of £11,154) but overall considering the Designated and Restricted Funds, there was a total deficit of £2683 (2022: Deficit of £8316). The principal source of regular income is by way of freewill envelopes, monthly standing orders and open plate. The regular giving by church members was slightly down when compared to 2022.

During the year tax was recovered on Gift Aid donations for the years 2020, 2021 and 2022, making a considerable increase to the reported income. The backdated years claims accounts for around £6,000 additional income in the year. The income includes the grants from the General Trustees for the repair to Winchburgh Church which has now been fully paid. Fundraising remains a challenge, our biggest increase in costs this year is heating and lighting.

A significant amount of money has been spent on professional services/fees to progress the internal alteration, to include a small kitchen and accessible toilet facilities, in Winchburgh Church which has been fully funded by the General Trustees.

There is further work to be carried out to the manse, including necessary repairs and upgrading, before a new minister is called, which will have a direct effect on cashflow.

Reserves Policy

It is the Trustees' policy to hold general reserves of at least £15,000. At the year end the Church held unrestricted cash funds of £19418 (2022: £26,011). The higher cash balance currently being held is in anticipation of the planned redevelopment work at Winchburgh Church. The Church also held £22,315 of restricted funds (2022: £18,405) which have been provided for the purposes specified in Note 2.

Statement of Trustees' Responsibilities

The members of the Kirk Session / Congregational Board must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session / Congregational Board are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and / or detection of fraud and other irregularities.
