Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Church of Scotland's Unitary Deed of Constitution. The former churches were administered under the Model Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session which meets approximately 6 times a year is responsible for all affairs within the church under the Unitary Constitution. Certain responsibilities are delegated to specific Committees as appropriate including Finance and Property.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

In addition to acts of worship each Sunday at 11.00am, approximately 100 in attendance and 6.30pm with approximately 20 in attendance, we also have a mid-week act of worship and fellowship on a Wednesday with approximately 12 in attendance. We continue to develop our online presence with the Sunday morning and Wednesday Worship services now being live streamed on our dedicated YouTube channel. Many of our stay-at-home members, and those who watch from various places in the world, appreciate this opportunity to worship and to remain a part of the life and worship of the church. Weekly prayer meetings and Bible Study groups add to our Christian commitment. There is a Crèche, and Young Church, which also meet on a Sunday morning.

A Brownies youth organisation meets on a Thursday evening. The Sunday Community café serves a simple meal to approximately 35 people per week. Broken Voices continues with approximately 12 members. Broken Voices have also formed a self-help group supporting one another's pastoral needs. The Baby and Toddler group and community choir, both are greatly supported and appreciated by the community. Many other groups from the community use the premises including, two Gaelic Choirs, AA, Al Anon, Gambler's Anonymous in person and on zoom, Slimming World, monthly Gaelic singing group and many Christian and secular groups looking for a meeting space. We are also members of the wider West End

Youth Group called 'The Wheel Trust' and an ongoing connection with Glasgow Street Pastors. In the McColl Halls, we now have a fully functioning Korean Church of Glasgow.

In terms of the charity's short term and long term aims, we seek to bring the ordinances of the Christian religion to the Parish that we are called to serve. We seek to work locally within the various Christian and secular community activities. We seek to continue to work alongside and with Partick Housing Association and The Annexe Community. The local Greggs support us with free bakery products for the Sunday café. One of the key principles of the church is to help and support the most disadvantaged and poorest members of society. We aim to achieve this by continuing to provide free meals, and a welcoming non-judgemental space.

On the 30th March 2023 Partick South Church entered into a union with Balshagray Victoria Park Church [BVP]. This union included the oversight and potential usage of the BVP Church building renamed as The Balshagray Centre. The Balshagray Centre hosts various organisations, Brownies, Girl Guides, Glasgow Chambers Orchestra, a children's ballet class and an adult exercise class.

The Balshagray Centre has a number of building issues that will be looked at in 2023 and into 2024, as the Trustees decide how best to move forward to achieve their missional aims

The Trustees believe that they are fulfilling their short term aims, as well as building a solid foundation for long-term sustainability.

Achievements and Performance

2023 was a year of challenge and change as two congregations came together in a union. The church continued to open on a Sunday evening to feed the homeless and those in need within our community by offering them a free hot meal, refreshments, bakery products and second-hand clothing. Approximately 35 people attend. The members of the congregation support this by giving financially, as well as giving of their time and talents. The Café is also supported by local businesses: Deoch & Dorus Public House, and Greggs bakery.

This venture is staffed by volunteers from within the church membership, as well as members of the wider Partick community and from the recovering community. Our Sunday morning service and Wednesday worship, were both offered as online or via live steaming service on YouTube. The September Harvest Offering for the Lodging House Mission was a mixture of pre-packed groceries or a financial offering, we also supplied over 150 Easter Eggs.

We also fundraised for various missional priorities such as Compassion UK where we support 3 children, a Health Centre in Burundi, a Ukrainian church in Odessa, as well as donating a generator to such church.

The church grounds are maintained by a small dedicated group of church members As the charity has leased the old building, known as the McColl Halls, to the Glasgow Korean Church, they are now in year 7 of a 10-year lease, previously completing a 5-year lease. Many general building repairs were made to keep the Sanctuary and halls

in good order with no significant spend. The Manse also had various minor repairs attended to and some rooms decorated. A new kitchen was installed in 2023, with further upgrades to the conservatory roof and backdoor patio planned in 2024. The manse is well maintained and kept in good order. The Minister conducted 15 funerals. The church continues to look at various ways of expending its presence on various social media and online platforms. We have also been working locally with our cluster churches Scotstoun Parish Church and Whiteinch Parish Church. We have held joint Pentecost Praise evening and seasonal Bible studies. We aim to strengthen our partnership in the years to come.

In the forthcoming year we intend to fulfil our social and spiritual aspirations abiding by our mission statement, "Making Jesus known - by praising His name, teaching His word, reaching His people, serving His church, supporting His family".

Financial Review

An initial look at the accounts shows overall income increased by almost £100k, with details given in notes 2 to 5, while expenditure was up by £80k, with details given in note 6, resulting in a deficit for the year of £27k compared with last year's deficit of £43k. Clearly the ongoing activities of the united charge is a significant factor but due to the method of accounting, explained in note 1 the figures are not strictly comparable. The key difference is seen in note 4 which brings in the £70k of cash funds held by BVP at the date of the union. These represent the results of many years of service, not a one-day event in 2023. The accounts also reflect the transfer of BVP's investments of £47k detailed in note 8. It is pleasing to note that our investments have recovered much of the losses they suffered last year. In these days when the ongoing cost of living financial climate continues to affect people, especially those on fixed income, we would record our thanks to all for their financial support and also thank all the volunteers whose efforts have helped in running the church this year.

Reserves Policy

The charity trustees have considered the reserves required and have taken into account their current and future liabilities. It is the Trustees' policy to hold cash reserves of approximately 6 to 12 months expenditure including designated funds. At the year-end the church held unrestricted funds of £156,752 of which £5,509 had been designated for the Fabric and Compassion funds as shown in Note 7. The balance is split between the General Fund (£47,885 in bank) and the Investment Deposit Fund (£103,359 with COSIT) which is considered satisfactory.

The church also held £31,868 of restricted funds and £15,812 of endowment funds which have been provided for the purposes specified in Note 7. We also have investments as shown in the Statement of Balances but the vast majority are classed as endowments and therefore the capital has to be preserved.

The Trustees are aware of the need to replace the furnishings in the Sanctuary, main hall and various other rooms, and may use the additional reserves for this purpose. The Trustees have made the decision to invest in people by offering various positions of employment to advance the mission of the church.

Trustees' Responsibilities in Relation to the Financial Statements

The Trustees must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The Trustees are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2016. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

I report on the accounts of the charity for the year ended 31 December 2023 which are set out on pages 8 to 12

Respective responsibilities of trustees and examiner

The charities trustees are responsible for the preparation of the accounts in accordance with the terms of the Charity's and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 [as amended].

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006 [as amended]. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

1 Basis of Accounting

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005, The Charities Accounts (Scotland) Regulations 2006 (as amended) and the Regulations anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2016.

They use the acquisition accounting method to deal with the union on 30 March 2023 of Glasgow: Balshagray Victoria Park Parish Church and Glasgow: Partick South Parish Church under the name of Glasgow: Partick Victoria Park Parish Church of Scotland using the Scottish Charity Number SC008315 (formerly that of Partick South). The accounts show the receipts and payments of the united charge from 30 March 2023 together with those of Partick South from 1 January 2023 to the date of union with the balance of funds held by Balshagray Victoria Park at the date of union separately disclosed as a receipt. Comparative figures show only the receipts and payments of Partick South.

Ian McFadyen Fund - This is a non-designated fund for general use.

Fabric Fund - This fund is designated for repairs and improvements of the church portfolio.

Legacy – for use as directed by the Trustees.

Purpose of Endowment Funds

Reginald Wells Account - This is a fund to be used for general purposes, the capital element of which must be preserved.

Ida Shearer Fund - This is a fabric fund to be used for church repairs, the c

8 Trustee remuneration and related party transactions

During the year Mrs Mary McIntyre who is a Trustee received a salary of £2,860, as an employee for providing administration support to the Treasurer, Minister and Church. Amounts expended in respect of the minister's travelling expenses or £1,287 and manse council tax of £3,225 were paid during the year.

No trustee or a person related to a trustee had any personal interest in any contract or transaction entered into by the charity during the year.

9 Minister's Stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review, the minimum stipend was £30,135 and the maximum stipend (in the fifth and subsequent years) was £37,032.
