Trustees Annual Report Year ended 31 December 2023

Structure, Governance and Management

The Church is administered in accordance with terms of the Deed of Constitution (Unitary Form), having transferred to this form of governance on 1st October 2012.

Recruitment and appointment of Trustees

Members of the Kirk Session are Trustees. They are the elders of the Church and are chosen from those members of the church who are considered to have the appropriate gifts and skills to be spiritual leaders of the congregation. The minister, who is a member of and moderates the Kirk Session, is elected by the congregation and inducted by the Presbytery.

Organisational Structure

Under the Unitary Form of constitution the Kirk Session is responsible for Spiritual and financial matters and discipline within the congregation. It meets at least five times a year.

Objectives

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in policy. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Social events were successful with car boot sales, afternoon teas and quizzes taking place, helping to build a real sense of community. We were delighted to once again hold a Christmas event with the Stirling Male Voice Choir performing in aid of Dementia Scotland.

Achievements and Performance

Regular worship attendance averaged around 33.

Financial Review

Church funds at 31 December 2023 showed an excess of receipts over payments of £20,887. This total included legacy contributions of £10,500.

Liabilities at 31 December 2023 are listed on page 6 and will be funded by this excess in receipts. Unrestricted funds had a surplus of £20,157, Restricted Funds a surplus of £686 & Endowment Funds a surplus of £44 during 2023.

Lecropt Church held Unrestricted Funds of £83,797, Restricted Funds of £16,713 and Endowments of £1,467 totalling £101,978 at 31 December 2023.

The Church also holds unrestricted investments with a market value of £13,578 (an increase from £12,576 in 2022) and endowment investments with a market value of £1600 (an increase from £1542 in 2022). In addition, funds are held on behalf of the Congregation by the Church of Scotland General Trustees and information is provided on page 9.

Reserves Policy

C

It is the Trustees' policy to hold unrestricted reserves of 6 months expenditure and at present holds reserves that will cover 24 months' expenditure

Statement of Trustees Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable and appreciate the transactions of the church during the financial year. The members of the Kirk Session are responsible for keeping accounting records which, on request, must reflect the financial position of the church at that time. This must be done to ensure that the financial statements comply with the Charity and investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and or detection of fraud and other irregularities.

Basis of independent examiner's statement




