The trustees fulfil the charitable purposes through provision of grant support to relevant organisations. The trust supported the following organisations during the year –

#### **Financial review**

Total income rose slightly during the year. Charitable expenditure was well short of income due to timing issues and is expected to be ahead of income for 2025/26.

#### Trustee remuneration and other expenses

The trustees did not receive any remuneration or expenses during the year. All administration was carried out by one of the trustees of the trustees of a pro bono basis.

### **Assets and Reserves**

The market value of the Trust Fund rose slightly during the year but has since fallen due to market uncertainty relating to US tariff intentions.

In normal times the trustees aim to maintain a modest cash reserve of c.£20,000 to enable grant support in excess of annual income to be offered in exceptional circumstances. Cash reserves rose sharply due to timing issues and are expected to fall again in 2025/26.
