#### **Objectives and activities**

#### Charitable purposes

The charity is established to assist individuals in poverty or at risk of poverty, or who are in need by reason of age, ill-health, disability, financial hardship or other disadvantage by providing hot meals, accommodation, community support, signposting support, employment and skills training and drop-in cafes for such people whether they are homeless or otherwise vulnerable or in need and by providing such other support services as the trustees in their sole discretion consider appropriate, including (but not limited to) the provision of meals, clothing, education and guidance.

#### Summary of the main activities

Our main activity is hosting healthy, home-cooked meals in churches across the city of Edinburgh and also, recently in Livingston. We work with Life Church Edinburgh, Carrubbers Christian Centre, Mustard Seed Edinburgh, Central Church, Oxgangs Community Church, Edinburgh City Mission, St Mary's Episcopal Cathedral. Further afield, we work with Livingston United Parish Church and with B&A Church in Bristol.

There are meals held six days a week across the City of Edinburgh. We support all the churches who host Soul Food meals in the recruitment of volunteers, training of volunteers, financial support, signposting help, and day to day availability with the general running of their meals, if required.

An exciting initiative this year has been to develop a book group working alongside our partners at the Simon Community and Street Reads.

#### Structure, governance and management

Soul Food Edinburgh is governed by a constitution adopted 02 August 2018

Trustee recruitment and appointment

Soul Food Edinburgh is entirely managed by the Trustees, who act in a voluntary capacity, completely independent of any other body.

There are a minimum of three Trustees, who alone appoint their successors, on a rolling basis.


#### **Achievements and performance**

In 2023/4 Soul Food Edinburgh continued to provide hot, delicious, home-cooked meals whilst also offering some respite and support to anyone dealing with the challenges of homelessness, poverty, isolation, and loneliness. Our vision is centred around the power of the table. By setting a table and sharing a meal, Soul Food Edinburgh hopes to provide a context that offers a place of safety and security where people feel accepted, respected, valued, loved, and heard. We hope that the ordinary setting of a dining place becomes a space of life-changing relationship and community.



Every Soul Food meal offers the warmest of welcomes to all people, whatever their situation. No referrals are needed to access a meal, they are open to anyone in need of a free meal and a safe space to be. This year we continued our meals at Life Church Edinburgh, Carrubbers Christian Centre, Mustard Seed Edinburgh, Central Church, Oxgangs Community Church, Edinburgh City Mission, St Mary's Episcopal Cathedral, Livingston United Parish Church and with B&A Church in Bristol. Over 500 people a week attend a Soul Food Meal. Most are living with the pressures of unsure housing arrangements. All have been hit hard by the cost-of-living crisis. Many live with uncertain mental health or the effects of addiction. Especially

for our older guests, the issues of loneliness and isolation remain a challenge. In the last 12 months we have provided more than 25,000 meals. One guest commented, 'You have an incredible reputation in this city. You are known for your kindness.' Another, 'There's something unusual about Soul Food. People treat you with such kindness and talk to you as an equal. That's not my daily experience of homelessness.'



Recognising that a meal meets the immediate need of hunger but does not address the long-term challenges that guests could be experiencing, we talk of being 'more than a meal'. Through the offer of friendship and community, we continue to offer specific support to individuals. In the past year anything from helping to open bank accounts, filling in forms, signposting to benefit and housing advice, providing supermarket vouchers, gas and electricity top ups, decorating flats and tech support. This has been achieved through our excellent volunteer teams and our partnerships with charities and other relevant organisations. We continue to work hard in training our volunteers, so that volunteering at Soul Food continues to be a lifegiving and life-enhancing experience. And throughout the year we offered training on how best to support and walk alongside our guests, practical food hygiene courses and naloxone training. We have also visited churches and community groups to help them understand how they can run community meals.



An exciting initiative this year has been to develop a book group working alongside our partners at the Simon Community and Street Reads. Up to 30 people regularly attend this group. With a cup of tea and a slice of cake, a lively discussion about the latest read is had. It is a much-appreciated addition to our work.

At the time of writing this report we are in a time of transition. Some of the venues we have been so grateful to use are not going to be available to us anymore. This means new venues along with new ways of doing Soul Food are being searched for. This will have a financial implication to the charity as we will have to start paying rent for our venues and fully paying for our new meals. Up to this point our venues have been free and provided at least 50% of the costs of the meals. This means we will be looking at new ways to raise the extra finance needed to cover our costs. It also means we are reviewing the staffing of Soul Food expecting to increase the staff team.

We continue to be grateful for all our guests, volunteers and trustees for getting us this far and we are looking forward to seeing how things develop over the next 12 months.

#### Statement of the charity's policy on reserves


Soul Food Edinburgh employ no staff and hold no assets. Therefore, there is minimal need for reserves other than to ensure restricted funds are used for the purposes specified by the respective donors.

#### Details of any deficit

During the year of this report, there was a net surplus of £12,461 (previous year deficit £5242). Although there was £10,800 of restricted funds carried forward for distribution in the next financial year, there was, nevertheless, a small surplus for the year.

# Independent Examiner's Report to the Board of Trustees of Soul Foods Edinburgh

I report on the accounts of the charity for the year to 31st March 2024.

#### Respective responsibilities of the Trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006(as Amended).

The trustees consider that the audit requirement of Regulation 10(1)(a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

#### Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006(as amended). An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
