Structure, governance and management

Type of governing document

The community organisation was originally constituted in 2007, and was recognised as a Scottish Charitable Incorporated Organisation with effect from 27th August 2012. The charity is administered in accordance with the terms of the SCIO constitution, adopted on 3rd April 2012.

Trustee recruitment and appointment

Five trustees were appointed on the establishment of the SCIO in 2012.

At the AGM on 7th April 2015, two of the original trustees remain. Two trustees resigned in 2014 and three new ones were elected in at the AGM in 2014. One resigned and one was elected at the AGM in 2015.

The Appointment and removal of trustees is in accordance with the Trust Deed which requires that at each AGM, all of the charity trustees must retire from office but may then be re-elected. The maximum number of charity trustees is 8 and the minimum is 3.

Objectives and activities

Charitable purposes

The purposes of the organisation are to develop and maintain Alyth Community Woodland (ACW) for the long-term benefit of the people of Alyth and surrounds; to encourage the use of Alyth Hill and Alyth Community Woodland for pedestrians, horse riders and cyclists; to promote the use of Alyth Hill and Alyth Community Woodland for educational purposes; to support and sustain wildlife; to provide, maintain and encourage the use of facilities for rural leisure pursuits on; to plant and maintain fruit trees and shrubs; to plant areas of native trees for coppicing; to promote Alyth Hill and Alyth Community Woodland to visitors.

Summary of the main activities in relation to these objects

Maintenance of the Community Woodland, monthly inspections of the bike park and bi-annual inspections of the play features were carried out. Installation of brown tourist signs giving directions to the bike park. Annual Making Tracks event 16th May, and first Celidh. Bike Club run weekly from April to September for 45 participants up from 30 in previous year. Trail maintenance and orchard maintenance sessions completed with volunteers. New bike park logo and website created to improve online promotion of facilities
