New arrangements were introduced for the regulation of **fundraising by charities in Scotland** in 2016. Charities are supported in these arrangements by the **Scottish Fundraising Standards Panel**.

In line with a commitment made when the new system was introduced, an external review of the regulatory system has been commissioned by the Scottish Government.

### **SCVO Cyber Essentials Grants Scheme**

SCVO are helping charities understand what it means to be cyber resilient and are opening up the SCVO Cyber Essentials Grants Scheme to help small to medium sized charities achieve Cyber Essentials accreditation.



You can apply for the SCVO Cyber Essentials Grant from 9am on 21 September 2017.

To qualify, you must meet the following criteria:

- SCVO Cyber Essentials Grants are available to registered Scottish charities with either their own internal IT support staff or with a contracted IT supplier.
- The maximum annual income threshold to receive the Cyber Essentials Grant is £4 million.
- It is the responsibility of the qualifying organisation to contact and contract a supplier to carry out the accreditation.

## Strong interest in charity annual reports and accounts



In August, we published figures that reflect the strong interest in the reports and accounts of Scottish charities.

They show that from April to July 2017, there were 12,455 views of charity

accounts published by us on our website. In total, annual reports and accounts from over 4,300 different charities were viewed.

However, this is not the only way that the public can view charity reports and accounts. Charites also have the option to provide a link to this information on their own website. So far, over 2,000 charities have a link to this information on their register entry. In many ways, this is the best option for charities, as they can publish the information without the redaction that OSCR is required to make due to data protection legislation. They can also choose to include other information on the webpage holding the accounts to show the positive impact of their work.

Everyone running a charity should be aware of the legal requirement to promote charitable status to the public.

To help charities do this in a clear and consistent way, we have produced a charity registration logo that can be downloaded **free** of charge and used on a charity's website, email signatures

and publications, including hard copy. Every logo contains the individual Scottish charity's number on it.

We have recently updated the logo to say 'Registered SCIO' when the organisation is a SCIO and included monochrome versions of the logo as well.

A case study would involve:


- a short text description of your charity's work
