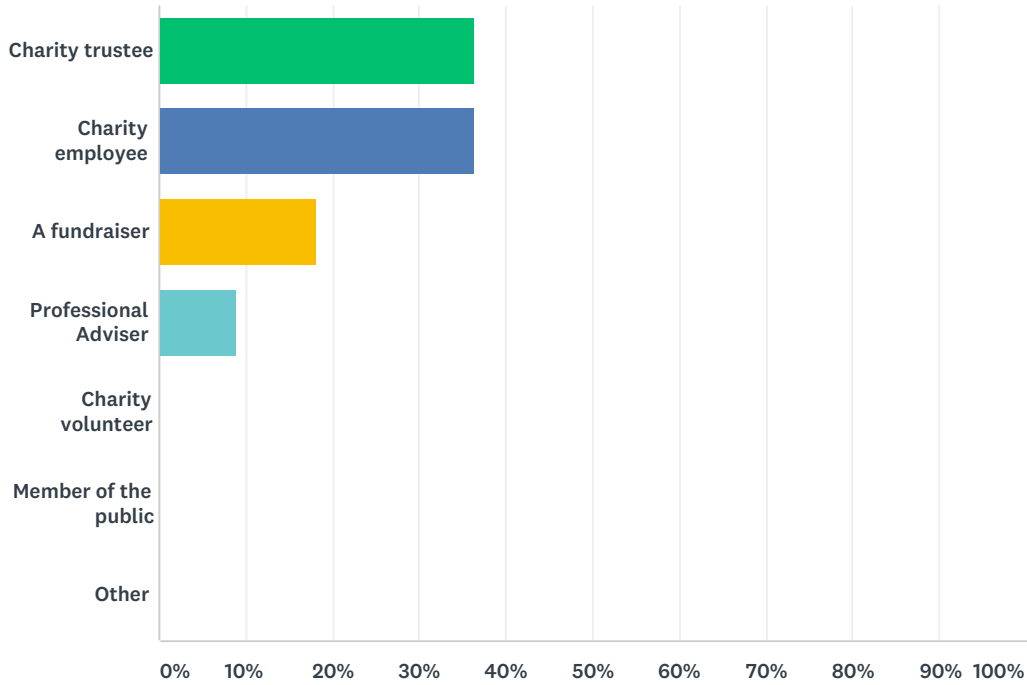

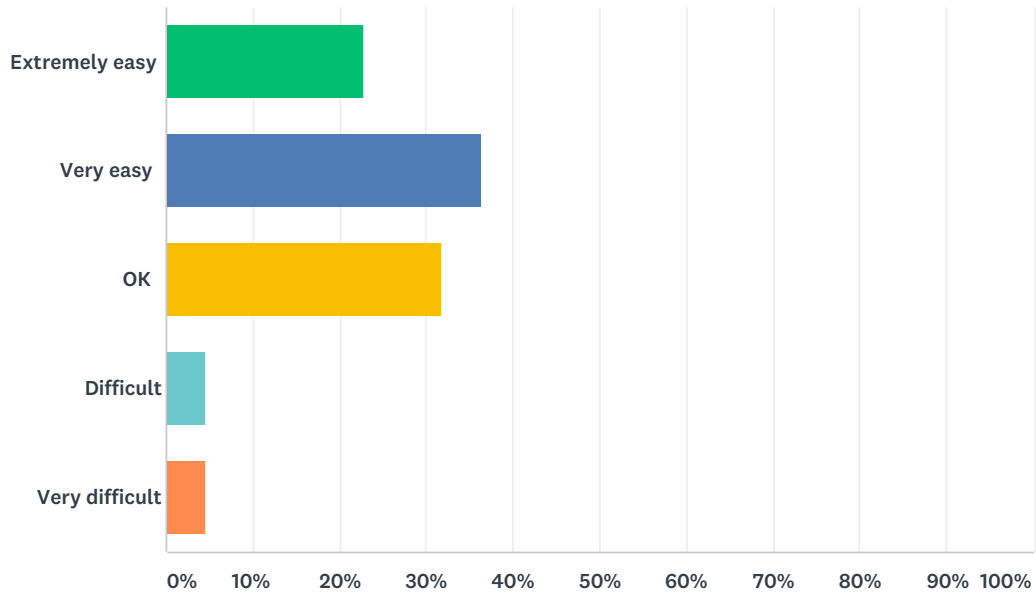

### Q3 Is the draft guidance easy to navigate?

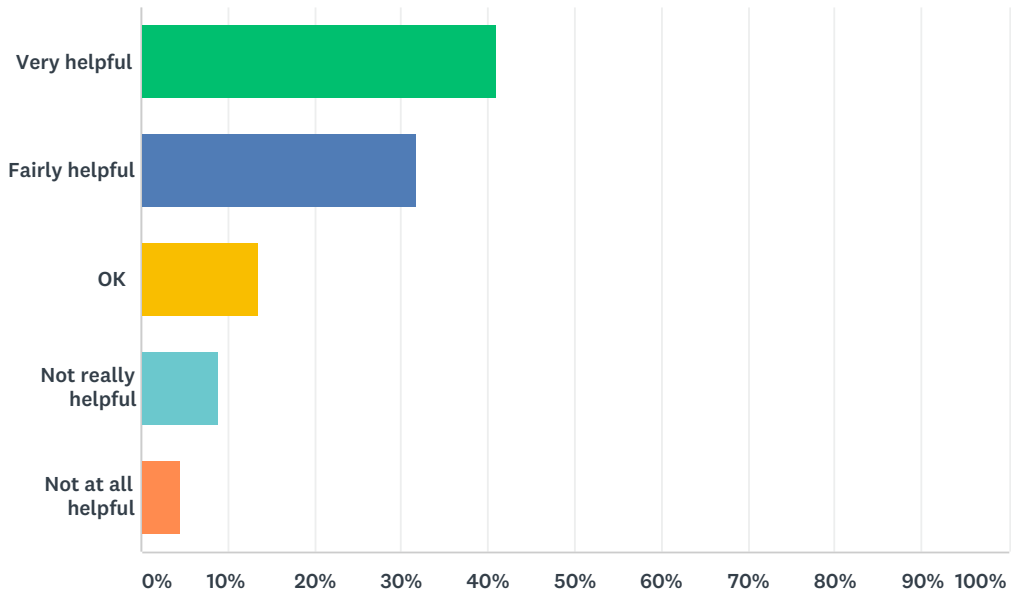

## Q4 Is the layout of the web-based draft guidance helpful?

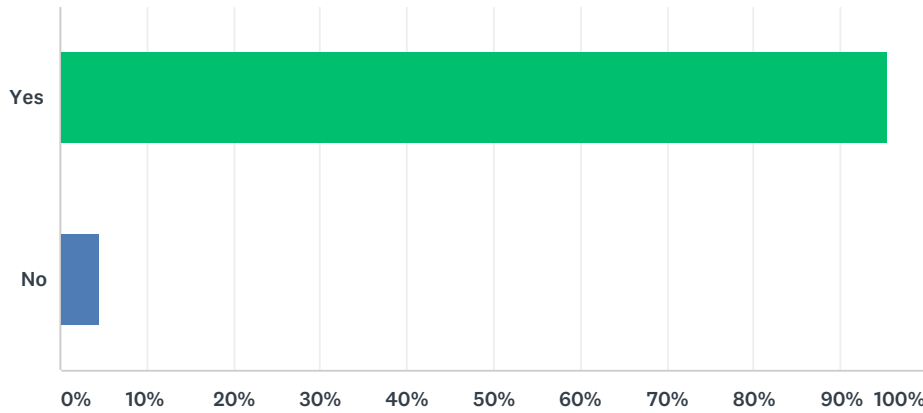

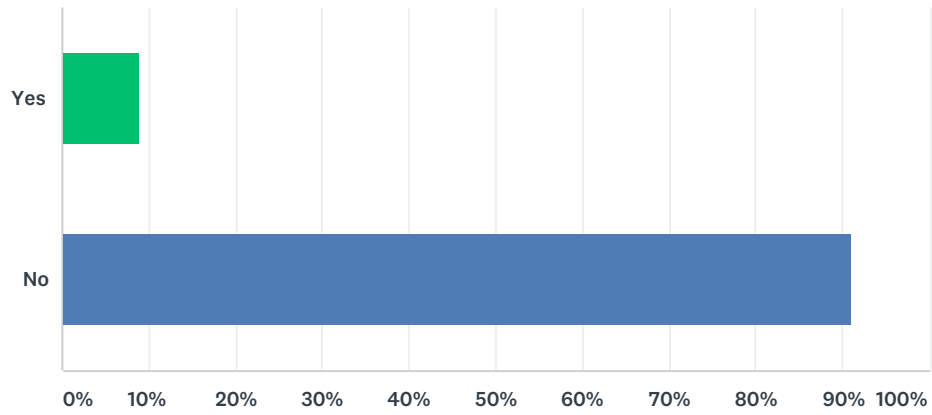

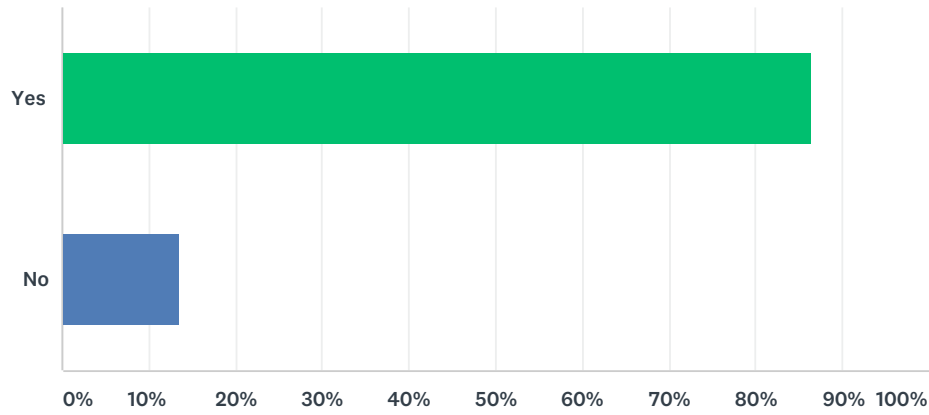

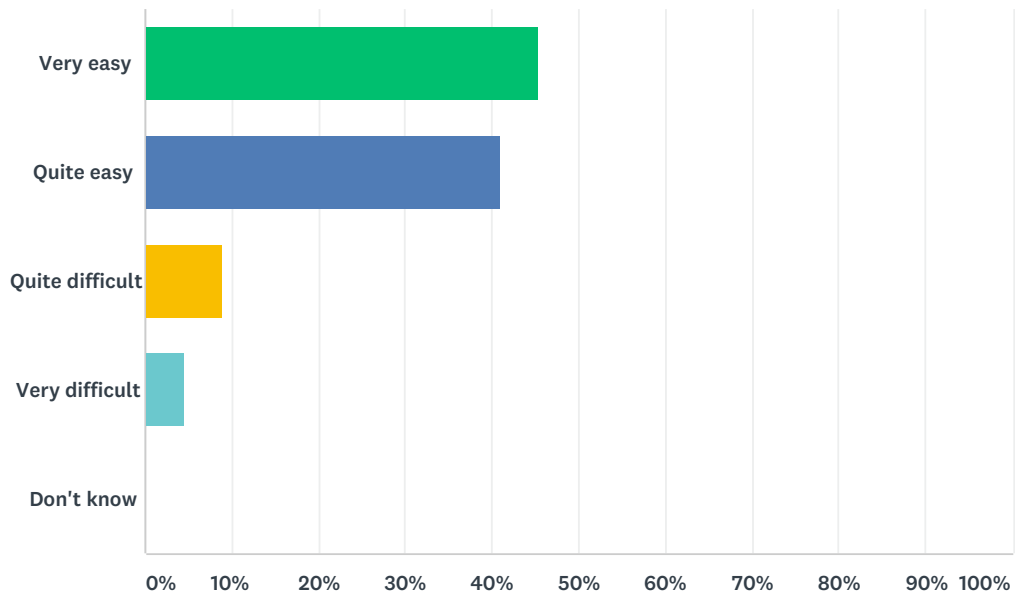
