#### OSCR publishes interim safeguarding guidance

The Scottish Charity Regulator (OSCR) has published interim guidance on safeguarding.

Safeguarding is the action that an organisation takes to promote the welfare of children and vulnerable



adults to protect them from harm. This includes making sure that the appropriate policies and procedures are put in place. Safeguarding includes child protection but goes further and extends to all vulnerable beneficiaries.

Safeguarding Guidance: Keeping vulnerable beneficiaries safe explains what is meant by safeguarding and highlights key steps charity trustees can take to make sure that it is considered in an appropriate way. The guidance also looks at how charity trustee duties set out in the Charities and Trustee Investment (Scotland) Act 2005 relate to safeguarding issues.

### Our survey says... public trust remains stable



Two surveys published by OSCR show that the public's score for trust in charities has remained the same since 2016 and confirms support from both the public and charities for OSCR and its work.

We commissioned the

surveys to see how attitudes compared to 2016. In the reports, independent research organisation Progressive presents the views of 1,000 members of the public and 1,200 charity representatives as well as findings from public focus groups and in-depth telephone interviews with charities.

We are currently travelling across Scotland to give charity trustees and staff the opportunity to hear about our latest developments, meet OSCR staff and ask questions.




In our 2018 round of events we are discussing a range of topics, including:

# Charity Tax Commission launches public call for evidence



The Charity Tax

Commission has launched a consultation seeking views on whether and how the tax treatment of charities — estimated to be worth around £3.7bn a year — needs to be reformed.

The review, the first systematic look at charity tax reliefs in over 20 years, will examine the role charities play in society, and seek to identify ways to improve the efficiency and efficacy of the current system.

The call for evidence will close on Friday 6 July. As part of the consultation, the commission will also be holding a series of public evidence-gathering meetings across the UK during the consultation period.

#### Consultation open on disclosure regime

Disclosure Scotland has launched a public consultation asking for feedback about proposals to simplify and modernise the Protecting Vulnerable Groups (PVG) scheme.



The 12-week consultation

closes on 18 July 2018. It is seeking views from stakeholders on a set of proposals, including how a mandatory PVG scheme would work, as well as membership duration and fees.

These rules also apply to any third parties who publish documents on behalf of your charity, for example legal advisors, accountants, or organisations working on your behalf.
