### Apply online to become a charity

On 05 March 2019, the Scottish Charity Regulator (OSCR) <u>launched its</u> <u>online application</u> to become a charity.

We have had lots of applicants using the service since then and we would like



to thank everyone who has taken the time to give us feedback so far.

For the first few weeks after the launch of the online application, we left the older pdf version of the 'Application to become a charity' form on our website as an alternative option. However, from 02 April 2019 that option has been withdrawn. We know that some potential applicants and advisors will have applications in progress using the pdf form, and we will continue to accept these applications until 30 April 2019.

OSCR strongly recommends that you get <u>advice</u> if you are thinking about setting up a charity. The new <u>Thinking about becoming a</u> <u>charity</u> section of our website takes potential applicants through the steps they need to think about before they start on application.

If you need help navigating the online application to become a charity, we also have <u>new guidance</u> that details how to log in to the online form and how to navigate it. For further questions about the form that the guidance does not answer, please contact us.

# Up to £1,000 available to charities to help defend against cyber attacks

A cyber fund is available to help charities and small and medium-sized businesses protect against the most common forms of internetborne cyber attacks.



Charities that are eligible can apply for up to £1,000,

which will support them to achieve the National Cyber Security Centre's Cyber Essentials or Cyber Essentials Plus accreditation.

Managed by the Scottish Council for Voluntary Organisations (SCVO) on behalf of the Scottish Government, the Cyber Essentials Voucher Scheme is available on a first come first served basis to organisations who meet the criteria. This is the second application round for the scheme following a successful round in November 2018. The deadline is Friday 26 April at 5pm. 
