In July 2017, we created a new personalised 'charity registration' logo to help you show the public that you're entered in the Scottish Charity Register.

This can be downloaded free of charge and used on your charity's website, email signatures and publications.

The logo has been downloaded over 30,600 times since launch. This has been a huge uptake and we want to keep the momentum going. That is why we are introducing a landscape version of the logo that may be more suitable for certain charities depending on their website/publication layouts. Like the current logo, it will come in three colours (including monochrome) and different file formats.

organisations and social
enterprises, whatever their
shape, size or activities. The



Code encourages trustees to look at, and improve, their governance, and is supported by practical resources. It is a tool to support continuous improvement and strengthen the effectiveness of governance across the third sector in Scotland.

**SCVO** have created a Good Governance Checkup document to be used in conjunction with the Code to help trustees regularly review their governance. Your board can use the checkup to identify areas for improvement and monitor and record your journey to good governance.

The Scottish Government's Families and Communities Fund will run from April 2020 to March 2023, with up to £16m being available annually.

(that are also a company limited by guarantee or a SCIO) which deliver work of national significance.

Applications must be received by 2pm on 24 September 2019. Only online applications received by this time will be accepted.

## **Inquiry Reports**



We have published two new inquiry reports on our website.

A brief description of each report is below.

1. Interim Inquiry Report -

### SC045522, Aspire Community Solutions

OSCR has issued a formal direction to the bank holding property on behalf of Aspire Community Solutions, a community regeneration charity based in Paisley, preventing it from parting with any property of the charity without OSCR's consent. This action was taken based on information we have obtained through an inquiry into the charity. OSCR are concerned that there has been misconduct in the

administration of the charity, and our inquiry remains ongoing. **Read** the interim section 33 report here.


### 2. Inquiry Report – SC043257 Heart Space Dundee (SCIO)

During an ongoing inquiry into the charity Heart Space Dundee (SCIO), we received a Notifiable Event from the charity trustees which indicated that the charity's assets might be at imminent risk of misuse. In December 2018 we issued a formal direction to the charity's bank as a protective measure while the charity trustees made arrangements to address the risk identified. The direction was revoked on receipt of information that the charity trustees took action to remove the risk to the charitable assets. **Read the section 33 report here**.
