Charities active in countering the impact of COVID-19



OSCR has published the findings of research into the impact of COVID-19 on Scotland's charities.

On 05 May 2020, OSCR emailed the principal contacts of all Scottish

charities to ask for their help with completing a short survey. The survey asked questions on the impact to the charity of coronavirus (COVID-19) and the subsequent lockdown measures. The research was conducted until 15 May 2020, with 4,827 responses providing insights from a large number and representative cross section of registered Scottish charities.

Reading annual reports and accounts of charities affected by COVID-19

The impact of COVID-19 on a charity's finances mean that they are unlikely to look similar or comparable to previous years. It is very important for anyone reading the accounts to understand the differences, particularly when considering potential donations or other funding.

Inquiry Report: Jobs and Business Glasgow



OSCR has published the findings of its inquiry into Jobs and Business Glasgow, Scottish Charity Number SC023930. Jobs and Business Glasgow (JBG) an 'Arm's Length External Organisation' (ALEO). An ALEO is a body

that is formally separate from a local authority but subject to its control or influence.

OSCR opened an inquiry into JBG in December 2015. Our regulatory interest was in whether the charity trustees had met their duties in ensuring there was appropriate financial oversight of the charity, and in making the decision as to whether to repay £4.3 million of funding from two EU funding streams to Glasgow City Council.

UK Regulators publish COVID-19 guidance for Independent Examiners

The UK Charity Regulators have issued joint guidance for independent examiners undertaking assignments that may be affected by the coronavirus (COVID-19) pandemic.



Guidance for Independent Examiners during COVID-19 pandemic or in a time of national emergency includes information on:

- practical issues arising from restrictions related to COVID-19, particularly the impact on access to records and access to those in management and control of the charity
- · areas that examiners should pay particular attention to

 implications for the examiner's report itself, and the sign off and filing of accounts.

The guidance is intended to supplement what has already been produced by the UK Regulators in relation to independent examination and should be read alongside this. OSCR's guides to Independent Examination are available here.
