Improvements to OSCR Online



OSCR Online is the system charities registered in Scotland use to submit annual information that will displayed on the Scottish Charity Register. Launched over a decade ago, it has given thousands of organisations a way to be

transparent about their activities throughout the year.

The system is due to be upgraded in the coming weeks. Although it will still be called OSCR Online, it has been rebuilt from the ground

up with a number of new features. The main changes for charity users are:

- A new look
- Charities will be given the option to nominate three individual users to access a charity's record, removing the need to share a charity's login details
- Links to our latest news and social channels

Moving to our improved system will take some time. OSCR Online will temporarily close for around one week to allow us to complete the upgrade. We will give charities advance notice of these dates when they are confirmed, but we would ask any charities with an annual return deadline in June or July to submit annual information now if it is at all possible.

Third Sector Governance Code Consultation



The Scottish Governance Code for the Third Sector was developed in 2018 and sets out five broad principles of good governance that act

as a point of reference for trustees in carrying out their role. They can be summarised under the following broad headings: Organisational Purpose; Leadership; Behaviour; Control; Effectiveness.

After COVID-19, so much digital change, the climate crisis, and a global demand for greater equality, diversity and inclusion, <u>Scotland's Third Sector Governance Forum</u> are looking for your views on whether the Code is still fit for purpose.

You can do this by completing this survey by 30 June 2022.

The survey is designed for those who are currently on a Board or Committee in the role of a Trustee or Director in addition to senior staff and volunteers who work with the Board to run the organisation. It is recommended that you have the <u>existing Code</u> available to you while completing the survey.
