Is your annual submission deadline coming up?

Every year, every registered charity in Scotland must send OSCR a set of accounts, a trustees' annual report and an external scrutiny report.



OSCR requires this information within 9 months

of a charity's 'year-end'. For example, when a charity has a financial year-end of 31 March its deadline date is 31 December. A significant number of charities have a deadline between December and January. It is clearly marked on a charity's entry in the Scottish Charity Register if they have missed their deadline.

Charities submit this information by completing an online annual return using OSCR Online. OSCR Online was upgraded on 25 July 2022, and the principal contact for a charity received new log in information around this date. When the principal contact accesses the upgraded system, they can add an additional two users who also have the ability to submit a charity's online annual return.

If you are the principal contact of a charity and you have not logged into the system yet, please do so now. More information is available here.

What happens if my charity is late?

In addition to displaying this information on their entry in the Scottish Charity Register, if a charity does not provide us with the required information the following could apply:

- under section 45 of the Charities and Trustee Investment (Scotland) Act 2005, we can appoint an accountant to prepare the accounts at the trustees' expense
- charities who submit their accounts after their deadline may experience difficulties in obtaining external funding, as many funders use the information on the register to inform their funding
- charities may not be able to access other benefits of charitable status, such as exemption from water rates.

New OSCR Chair appointed

The Scottish Government has announced that Marieke Dwarshuis has been appointed as the new Chair of OSCR.

Ms Dwarshuis succeeded the current Interim Chair, George Walker, on the 15th October 2022. The appointment will last for four years.



Marieke Dwarshuis' career in Scotland spans nearly thirty years in the public and voluntary sectors in a wide range of roles, including Director of Consumer Focus Scotland and positions at the Scotlish Government, OSCR, Citizens Advice Scotland and Shelter Scotland.

Marieke has also served as Chair of the Scottish Tribunals and Administrative Justice Advisory Committee. She brings extensive experience as a non-executive director having been a member of the Board of the Scottish Fire and Rescue Service and Food Standards Scotland and a board member of Hillcrest Housing Association Ltd.

Annual Report and Accounts 2021-22



In August, OSCR published its Annual Report and Accounts for the year 2021-2022.

The report shows our financial activity, sets out how we contribute to Scotland's National Performance Framework

and highlights progress against our corporate objectives.

Key facts and figures for 2021-22 include:

- A continued increase in the number of registered charities in Scotland (25,412 in 2021-22, compared to 25,230 in 2020-21)
- The percentage of charities late in submitting an annual return and accounts to us in 2021-22 was a substantial increase on prepandemic levels (13.5%)
- The number of concerns about charities which we received in 2021-22 increased to 563 from 426 in 2020-21 (for comparison 620 were received in 2019-20).

OSCR continued its work as an enabling regulator to Scotland's 25,000 charities over the period, while striving to ensure that public confidence in the sector remains high. We managed a significant change to our governance, with a number of long-standing Board Members reaching the end of their time in post, and worked to improve transparency around our important work.

New report on Charity Reserves Management



A new report from IVAR and the Scotland Funders' Forum finds that strategic management of charity reserves could enhance the stability and agility of the voluntary sector. As charities, funders and regulators consider how to respond to the cost of living

crisis – could reserves management unlock money to support change and development while also providing a protective financial buffer?

Key findings

There is considerable variation in charities' reserves management practice, which the report identified along a spectrum from 'basic' to 'strategic'. The report found that strategic reserves management is a core element to enhancing charities' ability and agility to meet changing needs; however they experience three key barriers/opportunities:

- Access to finance management skills
- Funding practices and income types
- Trustee caution and confidence
