### Is your annual submission deadline coming up?

Every year, every registered charity in Scotland must send OSCR a set of accounts, a trustees' annual report and an external scrutiny report.



OSCR requires this information within 9 months

of a charity's 'year-end'. For example, when a charity has a financial year-end of 31 March its deadline date is 31 December. A significant number of charities have a deadline between December and January. It is clearly marked on a charity's entry in the **Scottish Charity Register** if they have missed their deadline.

Charities submit this information by completing an online annual return using OSCR Online. OSCR Online was upgraded on 25 July 2022, and the principal contact for a charity received new log in information around this date. When the principal contact accesses the upgraded system, they can add an additional two users who also have the ability to submit a charity's online annual return.

If you are the principal contact of a charity and you have not logged into the system yet, please do so now. More information is available here.

#### What happens if my charity is late?

In addition to displaying this information on their entry in the Scottish Charity Register, if a charity does not provide us with the required information the following could apply:

- under section 45 of the Charities and Trustee Investment (Scotland) Act 2005, we can appoint an accountant to prepare the accounts at the trustees' expense
- charities who submit their accounts after their deadline may experience difficulties in obtaining external funding, as many funders use the information on the register to inform their funding
- charities may not be able to access other benefits of charitable status, such as exemption from water rates.

If your online annual return deadline is 31 December 2022, log in to your OSCR Online account now to make sure you have access.

Remember to submit your charity's annual return well ahead of the deadline if possible.

## 7 ways to speed up your application for charitable status

Each year, we add several hundred new charities to the Scottish Charity Register. But before your organisation can officially become a charity, you must submit an application for charitable status.



This process may seem daunting, especially if it's your first time registering a charity, but we're here to help. We've produced some top tips below to help you fill out your application correctly and ensure we can progress your application for charitable status quickly.

### **VACANCY: Data and Improvement Assistant**
