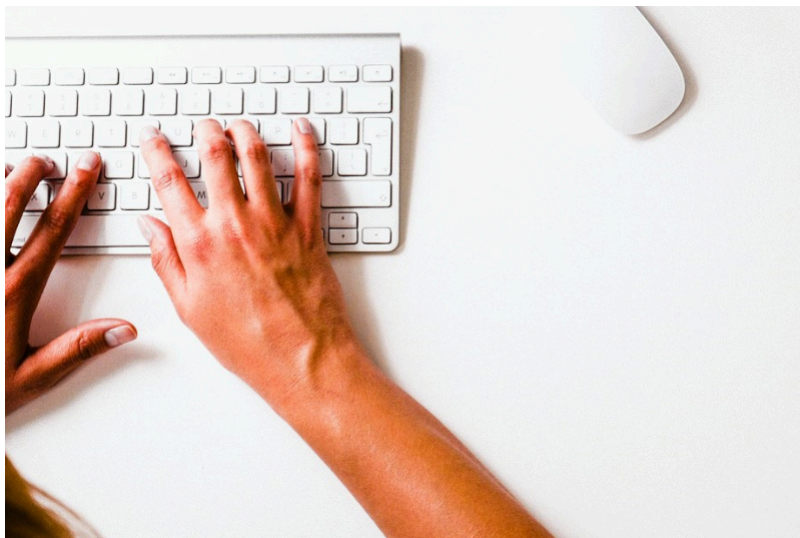

New OSCR Online features make charity trustee submissions easier

As of 30 June 2025, all Scottish charities are required to submit charity trustee information using OSCR Online. The response so far has been encouraging, with over 3,500 charities already providing their trustee details.

To support charities in meeting this requirement, we've [introduced two key improvements to OSCR Online](#). These updates make it easier to submit information for:

- Charity trustees based outside the UK
- Organisations acting as charity trustees

New automatic disqualification rules now in place

From 31 August 2025, [new rules on the automatic disqualification](#) of individuals from acting in Scottish charities came into force under the Charities (Regulation and Administration) (Scotland) Act 2023.

We published [updated guidance outlining the changes](#) and [announced the change](#) in May 2025. If you have not already done so, please review this guidance and take appropriate action if the new criteria apply to anyone in your charity holding the relevant roles.

The key changes are:

1. The automatic disqualification criteria will now also apply to individuals undertaking a senior management function.

2. The criteria for automatic disqualification has been extended.

Inquiry Report: Clan Donald Lands Trust (SC007862)

We have published the [findings of our inquiry into the Clan Donald Lands Trust \(SC007862\)](#) following the decision by the charity's trustees to sell significant landholdings on the open market.

The inquiry, opened in April 2025, focused on the charity trustees' decision making and financial context. OSCR found that the trustees acted within their legal powers and followed appropriate advice. As a result, OSCR will not be intervening and has now closed the inquiry.
